Dear Mesdames, dear Sirs,

I write under the instructions of the Tribunal, further to the Parties' respective communications of 26 February 2020, regarding corrections and designations of Confidential and Restricted Access Information in the hearing transcripts.

For the sake of completeness, the Claimant is invited to confirm its agreement with the Respondent's indications, set out in its 26 February 2020 communication, regarding the corrections to the transcript. The PCA will then prepare a final version of the hearing transcripts together with the court-reporters and will thereafter circulate it to the Parties.

As to the designation of confidential information in the transcript, the Tribunal reiterates its direction, as set out in its 3 February 2020 communication, that the Parties follow the procedure set out in paragraphs 23, 26, and 27, and Schedule 2 of the Confidentiality Order, and revert to the Tribunal once the confidentiality designations to the transcript have been agreed upon or require resolution by the Tribunal.
