# ARBITRATION BETWEEN EVEREST ESTATE LLC AND OTHERS AS CLAIMANTS AND THE RUSSIAN FEDERATION

THE HAGUE, 5 APRIL 2017

### The Tribunal Issues Its Decision on Jurisdiction

As reported previously (Press Release dated 13 January 2017), after the hearing on jurisdiction and admissibility was held in this matter in New York on 15 December 2016, the Tribunal invited the Parties to file post-hearing submissions to address any issues arising from the hearing by 31 January 2017.

On 16 January 2017, the Tribunal posed two additional questions to the Parties and invited them to file their responses together with their other post-hearing submissions. The Claimants filed their post-hearing brief on 31 January 2017. The Respondent did not file any post-hearing submissions.

On 20 March 2017, having deliberated, the Tribunal issued its unanimous Decision on Jurisdiction.

**Background:** The above-referenced arbitration was commenced by the Claimants against the Russian Federation pursuant to the Ukraine-Russia BIT and in accordance with the UNCITRAL Arbitration Rules 1976 on 19 June 2015. The Claimants contend that, as of August 2014, the Russian Federation breached its obligations under the Ukraine-Russia BIT by interfering with and ultimately expropriating their investments in real estate located in Crimea.

The Tribunal was constituted on 27 October 2015. It is comprised of Dr. Andrés Rigo Sureda (Presiding Arbitrator), Professor W. Michael Reisman (appointed by the Claimants), and Professor Dr. Rolf Knieper (appointed by the appointing authority, Mr. Michael Hwang, on behalf of the Respondent).
