Dear Mesdames, dear Sirs,

I write on behalf of the Tribunal, further to the Respondent's communication of 3 July 2020, confirming its agreement with the Claimant's 26 June 2020 request for an extension of certain deadlines set out in Procedural Order No. 4.

The Tribunal approves the agreed adjustments to the procedural schedule, and directs that the Parties file, by no later than the dates indicated below, the following written submissions:

- Claimant's Memorial – **Friday, 7 August 2020**;
- Should the Respondent wish to pursue bifurcation of the proceedings after having had sight of the Claimant's Memorial, the Respondent is to file its detailed objections on jurisdiction and a request for bifurcation by **Monday, 21 September 2020**;
- If the Respondent files a request for bifurcation, the Claimant is to file its response to the Respondent's request for bifurcation by **Monday, 12 October 2020**.
