Hearing on Jurisdiction

The hearing on jurisdiction in the arbitration instituted by Professor Christian Doutremepuich and Antoine Doutremepuich against the Republic of Mauritius will be held from 12 June to 13 June 2019 at the seat of the Permanent Court of Arbitration ("PCA"), at the Peace Palace, The Hague, in the Netherlands.

The arbitration proceedings are being conducted pursuant to the Arbitration Rules of the United Nations Commission on International Trade Law 1976 (the "UNCITRAL Rules"), the UNCITRAL Rules on Transparency in Treaty-based Investor-State Arbitration 2014 (the "UNCITRAL Transparency Rules"), and the Agreement between the French Government and the Government of the Republic of Mauritius on the protection of investments 1973 (the "Agreement").

The hearing will address the objections to the Tribunal's jurisdiction raised by the Republic of Mauritius.

Background of the Dispute

By Request for Arbitration dated 30 March 2018, Professor Christian Doutremepuich and Antoine Doutremepuich instituted arbitral proceedings against the Republic of Mauritius pursuant to the UNCITRAL Arbitration Rules and the Agreement.

The Tribunal is composed of Professor Maxi Scherer (Presiding Arbitrator), Professor Olivier Caprasse and Professor Jan Paulsson.

The PCA has 122 Contracting Parties. Headquartered at the Peace Palace in The Hague, the Netherlands, the PCA facilitates arbitration, conciliation, fact-finding, and other dispute resolution proceedings among various combinations of States, State entities, intergovernmental organizations, and private parties. The PCA's International Bureau is currently administering three inter-state disputes, 101 investor-State arbitrations, and 49 cases arising under contracts involving a State or other public entity and two other disputes.
