Dear Members of the Tribunal,

Further to the Claimant's email below, Canada obtained a copy of the *MAKAE Europe SARL v. Kingdom of Saudi Arabia* Award (the "Award") through Investment Arbitration Reporter (IAR), an online subscription-based source. On its website, IAR does not provide details on how it accessed the Award. However, it does not indicate that either of the disputing parties in the case objected to IAR accessing, summarizing, and providing a link to the Award on its website. Nor does IAR indicate that the Award is not public. The Award remains available on IAR's website. We hope this clarifies the circumstances surrounding Canada's possession of the Award. Canada would be pleased to provide a copy of the Award to the Claimant if it does not have access to IAR if the Tribunal so directs.
