WHEREAS on 2 February 2023, the Court of Arbitration (the "Court") issued its Procedural Order No. 1 ("PO1"), determining that the Court would conduct a preliminary phase of the proceedings to consider the competence of the Court and the operation of Article IX of the Indus Waters Treaty 1960, on an expedited basis (the "Preliminary Phase on Competence");

WHEREAS in PO1, the Court fixed a schedule for further written submissions and an oral hearing in the Preliminary Phase on Competence ("**Hearing on Competence**"), with the Hearing on Competence set down for 11 May 2023 to 13 May 2023 at the Peace Palace, The Hague, the Netherlands (with 13 May 2023 as a reserve day);

WHEREAS on 26 April 2023, the Court invited the Parties to address a list of questions in their oral submissions at the Hearing on Competence;

WHEREAS on 2 May 2023, the Court issued its Procedural Order No. 3 ("**PO3**"), fixing the schedule for the Hearing on Competence, subject to any changes the Court deemed necessary or appropriate for the efficient conduct of the Hearing;

WHEREAS in PO3, the Court allowed the Parties, with leave of the Court following a reasoned application, to rely on supplementary materials during the Hearing on Competence, having regard to the questions transmitted to the Parties for response at the Hearing;

WHEREAS on 5 May 2023, the Court issued its Procedural Order No. 4 ("**PO4**"), amending the schedule for the Hearing on Competence, given that India had not confirmed its participation in the Hearing;

WHEREAS on 7 May 2023, Pakistan requested an extension of time for Pakistan's oral submissions at the Hearing on Competence;

WHEREAS on 8 May 2023, Pakistan made an application for leave of the Court to rely on supplementary materials at the Hearing, comprising the exhibits and legal authorities identified in Annex A appended to this Order ("**Supplementary Materials**");

THE COURT OF ARBITRATION HEREBY DECIDES:

1. Further Amended Schedule for the Hearing on Competence

- 1.1 Having regard to the questions transmitted to the Parties for response at the Hearing on Competence, and the available time in the Hearing Schedule, Pakistan's request for an extension of time for its oral submissions at the Hearing on Competence is **granted**.
- 1.2 The schedule for the Hearing shall be further amended as follows:

2. Supplementary Materials

- 2.1 The Court has taken note of Pakistan's explanations as to the relevance of the Supplementary Materials to the questions transmitted to the Parties for response at the Hearing on Competence.
- 2.2 The Court further notes that India (or India's Commissioner for Indus Waters) is stated to be an author or recipient, or otherwise to be in possession of, the factual exhibits sought to be introduced (with the exception of a short explanatory note (item 68)), and that the legal authorities sought to be introduced are stated to be from publicly available sources.
- 2.3 In light of the above, and further to paragraph 3.5 of PO3, Pakistan's request for leave to introduce the Supplementary Materials into the record of the proceedings is **granted**.
- 2.4 Pakistan shall transmit an electronic copy of the Supplementary Materials to India and the PCA in accordance with Article 21 of the Supplemental Rules of Procedure as soon as practicable and in any case by <u>midnight (CEST)</u> on <u>9 May 2023</u>, with USB flash drives containing the Supplementary Materials to be submitted to the PCA within 10 days in accordance with Article 21(2) of the Rules.
- 2.5 The Supplementary Materials shall be numbered, formatted, and organized in accordance with Article 20 of the Supplemental Rules of Procedure.

3. Leave to Apply

- 3.1 Any Party has leave to apply to the Court for a variation of this Order, giving particulars of the variation sought and the reason for it.
- 3.2 Any Party may, at any point prior to the Hearing on Competence, request that the Court convene a conference with the Parties to address any procedural aspect of these proceedings. The Court

will arrange to confer with the Parties in person or by videoconference, according to the circumstances.
