As stated in Oficio N° 463-2022-EF/32, Peru reserves all rights, including any jurisdictional objections, for Claimant’s failure to satisfy the requirements provided in Article 10.15 (Consultation and Negotiation) and Article 10.16 (Submission of a Claim to Arbitration) of the TPA, prior to commence this arbitration proceeding.

Peru takes this opportunity to inform that it has already commenced the internal procedure to designate external counsel for this matter. The Special Commission anticipates that it will appoint Peru’s counsel before October 18, 2022, and will confer with Claimant on
